UBER AND LYFT AIN'T WHAT IT USED TO BE

Many of us used to make good money taking people to or from the airport as a Uber or Lyft driver. A few trips a day could put some nice cash in your pocket and you were on your way to do other things you cared, about giving you time freedom. Now ride sharing apps Uber and Lyft must classify drivers as employees rather than independent contractors and pay them minimum wage instead.

No one wants to work for someone else's dream to earn minimum wage and remain living at or below the poverty line. Don't wait until these changes affect you. Many drivers have left the rideshare circus to become travelpreneurs so they can set their own hours and determine their own worth.

Both Uber and Lyft have threatened to pull out of California if forced to comply. "Uber and Lyft have used their muscle and clout to resist treating their drivers as workers entitled to those paycheck and benefit protections," California Attorney General Xavier Becerra said. The two companies have 30 days to comply once the appeals process is fully exhausted. However they are backing the Proposition 22 ballot on Election Day which gives Californians a chance to vote of the status of gig economy workers. That may be the last opportunity to overturn it.

COVID-19 AIR TRAVEL IS SAFER THAN YOU THINK

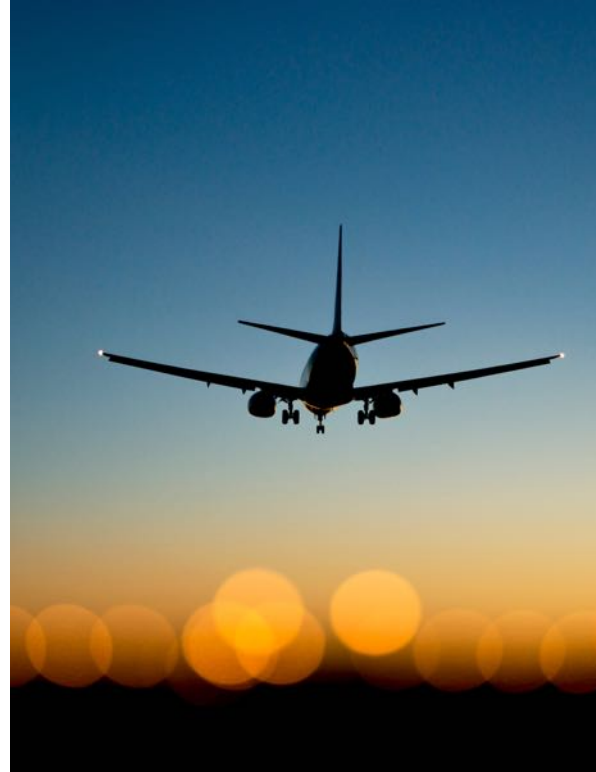
The International Air Transport Association has claimed only 44 COVID-19 cases have been transmitted during a flight - out of 1.2 billion passengers. These figures translate to 1 case for every 27 million passengers, or 0.0000036%.

"The risk of a passenger contracting COVID-19 while onboard an airplane is very low," IATA Medical Advisor Dr. David Powell said. IATA's 'outreach to airlines and public health authorities combined with a thorough review of available literature' has not suggested any widespread onboard transmission. "We think these figures are extremely reassuring. "Even more encouraging, he added, is that the published data occurred before the widespread wearing of face masks on aircraft and in airports.

New insight into why the numbers are so low emerged following research conducted by Airbus, Boeing and Embraer. All three plane makers claimed aircraft airflow systems control the movement of particles in the cabin, limiting the spread of viruses. Despite slightly different methodologies, the research claims aircraft airflow systems, specialized filters, the natural barrier of the seatback, the downward flow of air and 'high rates of air exchange' reduce the risk of disease transmission inside the cabin.

"The addition of mask-wearing amid pandemic concerns adds a further and significant extra layer of protection, which makes being seated in close proximity in an aircraft cabin safer than most other indoor environments," IATA concluded.
